Criteria

A real estate investor is eligible for a Golden Visa if he/she fulfills the following criteria:

 Must fully own a real estate property or properties of a minimal value of USD540,000 without a mortgage

AND

 Must maintain the investment for at least 2 years after the issuing of the Golden Visa

A mortgage is permitted for real estate property worth more than USD540,000. Regarding mortgaged property, the value of the investor's capital needs to be at least USD540,000. For instance, if a property is worth USD1,350,000, the outstanding mortgage principal cannot exceed USD 810,000.

There's also a non-property Golden Visa by Nomination available in Ras Al Khaimah (RAK). Here, a USD30,000 donation qualifies you for UAE Residency by Investment.

Requirements

The required documents from the investor are as follows:

- Passport
- Availability of an Electronic Copy of the Title Deed Certificate
- Personal Photo
- · Police Clearance
- · Copy of Latest Visa in the UAE (if applicable)

Terms and Conditions

Terms and Conditions for issuing a visa include the following:

- Letter from the Real Estate Registration Department in the relevant emirate stating that they own one or more properties whose value is not less than USD540,000, stating that the property is not subject to a loan
- Proof of housing in the country (home ownership or house rental contract)



Property Investment - Investor Visa

Invest a minimum of USD202,500 in real estate. This investment entitles applicants to an investor visa for three years that can be renewed if the investment is maintained.

Spouse, parents, and children can be included in the application with the same conditions. Parents of the applicant can also be included, though they will have a one-year renewable visa.

Considerations

The main applicant must:

- · Be at least 18 years of age
- · Purchase property, contribute to public investments, or set up a business in the UAE
- Meet the UAE Investor Visa Programme requirements
- · Have valid travel documents

Property Investment - Golden Visa

Invest a minimum of USD540,000 in real estate. This investment entitles applicants to a Golden visa for ten years that can be renewed if the investment is maintained.

Spouse, parents, and children can be included in the application with the same conditions. Parents of the applicant can also be included, though they will have a one-year renewable visa.

The main applicant must:

- · Be at least 18 years of age
- · Purchase property worth at least USD540,000
- Must maintain the investment for at least 2 years after the issuing of the Golden Visa
- · Meet the UAE Golden Visa program requirements
- · Have valid travel documents

This programme is not a route to citizenship of the United Arab Emirates.
